Florida's July Employment Figures Released

TALLAHASSEE – Florida's seasonally adjusted unemployment rate for July 2009 is 10.7 percent. This represents 987,000 jobless out of a labor force of 9,193,000. The unemployment rate is unchanged from the revised June rate of 10.7 percent and is up 4.4 percentage points from the July 2008 rate. The state's current unemployment rate is 1.3 percentage points higher than the national unemployment rate of 9.4 percent. The last time the unemployment rate was higher than June and July of 2009 was October 1975 when it was 11.0 percent.

Florida's total nonagricultural employment in July 2009 is 7,354,800, representing a job loss of 401,100, or -5.2 percent compared to July 2008. This is steeper than the national rate of decline for July which is -4.2 percent over the year. The July 2009 job loss continues the trend of annual declines that began in August 2007. The downturn started with declines in construction jobs, but has now spread to almost all other major industries.

"The Agency for Workforce Innovation continues to infuse federal stimulus funds directly to Floridians and into our economy through our Offices of Unemployment Compensation, Workforce Services and Early Learning to help meet critical needs during this extraordinary time," said Agency Director Cynthia R. Lorenzo. "Through our Unemployment Compensation Division alone, we have already paid \$944.5 million in benefits funded through the American Recovery and Reinvestment Act to 752,377 Floridians, resulting in a positive impact of \$1.5 billion to Florida's economy."

National economic experts estimate that for every \$1 in unemployment compensation benefits paid, there is a positive impact of \$1.63 on the local economy. Using this equation, AWI estimates a positive economic impact of \$1.5 billion resulting from the current total of \$944.5 million in Recovery-related unemployment payments.

Below is a listing of some of the American Recovery and Reinvestment Act programs the Agency for Workforce Innovation is currently administering:

American Recovery and Reinvestment Act Funds at Work

- **Extended Benefits:** Since July 2, AWI has paid an estimated \$207.4 million to more than 89,500 Floridians. It is estimated that \$418 million will be paid by the end of the year.
- Additional \$25 weekly: Since March 19, AWI has paid more than \$291.6 million in Federal Additional Compensation to more than 752,000 Floridians. It is estimated that \$345 million will be paid by July 2010.
- Emergency Unemployment Compensation: To date, AWI has paid \$445 million in federal Emergency Unemployment Compensation (EUC) to 627,000 Floridians under the provisions of the American Recovery and Reinvestment Act.
- Workforce Services: \$165 million in workforce services are being used to meet the needs of local communities for enhanced job placement and job training services, including <u>summer youth programs</u>, adult employment programs that match job seekers with businesses and additional services at One-Stop Career Centers.


- Grant funding: AWI recently received a \$3.1 million Re-employment and Eligibility Assessment (REA) grant
 to be used in conjunction with stimulus funds to provide unemployment compensation customers additional
 assistance in finding jobs. The REA grant will allow local One-Stop Career Centers to increase staffing to
 conduct in-person assessments of unemployed Floridians to provide a more focused job search. This grant
 expands the number of Regional Workforce Boards offering these specialized services from six to 19 of the
 state's 24 regions.
- Early Learning: \$105 million will provide approximately 20,000 high-quality early learning slots for children so income-eligible parents can work. The funds also provide for system enhancements to better serve children and families.

Florida's Nonagricultural Employment by Industry (Seasonally Adjusted)

- The number of jobs in Florida is down 401,100 in July 2009 compared to a year ago. The industry losing the most jobs is trade, transportation, and utilities (-99,100 jobs, -6.3 percent).
- Other industries losing jobs over the year include: professional and business services (-90,600 jobs, -7.9 percent); construction (-78,900 jobs, -15.6 percent); manufacturing (-42,300 jobs, -11.4 percent); leisure and hospitality (-40,400 jobs, -4.3 percent); financial activities (-23,200 jobs, -4.4 percent); information (-12,900 jobs, -8.3 percent); total government (-9,900 jobs, -0.9 percent); and other services (-9,000 jobs, -2.7 percent).
- These industry job losses are partially due to weakness in motor vehicle and parts dealers; employment services; specialty trade contractors; fabricated metal product manufacturing; amusement, gambling, and recreation; credit intermediation; publishing; local government; and repair and maintenance.
- Private education and health services (+5,400 jobs, +0.5 percent) is the only sector gaining jobs among Florida's major industries. All of the increase is due to health care and social assistance (+9,400 jobs, +1.0 percent), primarily in nursing and residential care facilities. Private education declined by 4,000 jobs (-2.9 percent) over the year.

Local Area Unemployment Statistics (Not Seasonally Adjusted)

- In July 2009, Liberty County has the state's lowest unemployment rate (5.9 percent), followed by Monroe and Walton counties (6.6 percent each); Franklin and Okaloosa counties (7.1 percent each); Wakulla County (7.2 percent); and Alachua, Jackson, and Leon counties (7.6 percent each). Many of the counties with low unemployment rates have a relatively high percentage of government workers and higher tourism during the summer months.
- Hendry County (16.4 percent) had the highest unemployment rate in Florida in July 2009, followed by Flagler County (15.9 percent), Indian River County (15.0 percent), and St. Lucie County (14.7 percent). Hernando and Lee counties followed with unemployment rates of 13.2 percent each. The counties with high unemployment rates have either seasonal declines in agriculture or continued weakness in construction and manufacturing.

Area Nonagricultural Employment by Industry (Not Seasonally Adjusted)

- All metro areas in the state lost jobs over the year in July 2009. Metro areas with the largest annual declines include Miami-Ft. Lauderdale-Pompano Beach (-82,500 jobs, -3.6 percent); Orlando-Kissimmee (-59,800 jobs, -5.6 percent); and Tampa-St. Petersburg-Clearwater (-55,600 jobs, -4.6 percent).
- The Palm Coast MSA (-1,200 jobs) has the smallest annual decline in number of jobs. The Tallahassee MSA has the smallest rate of job decline, -2.7 percent over the year.

Note: These unemployment and job growth rates are estimates, which are primarily based on surveys created and mandated by the US Bureau of Labor Statistics in cooperation with the Florida Agency for Workforce Innovation.

The unemployment rate is derived from Florida household surveys conducted by the US Census Bureau under contract with the US Bureau of Labor Statistics. The job growth rate is derived from Florida employer surveys conducted by the US Bureau of Labor Statistics.

Both estimates are revised on a monthly basis. In addition, these estimates are benchmarked (revised) annually based on actual counts from Florida's Unemployment Compensation tax records and other data.
